Ladies Day on the Range

Ladies Day was held June 6th at Laura Kiehl's ranch SE of Winnett. there were 16 attendees and 5 presenters. Allison Martin (MWC) kicked off the event with an EZ Ject Michelle presentation. Grocke (MSU-Extension) discussed Agriculture related mental health issues and ways to cope with stress. She provided the ladies with handouts that included tools, and exercises, and went through a "Mental Wellness Menu" checklist. Megan Hoyer (Yellowstone Co. Weed District) and Pam Schwend (Carbon Co. Weed District) put on an entertaining rendition of noxious weed eradication, followed by a field trip on the Kiehl ranch identifying noxious weeds. Sara Degn (Fresh Hopped Farms) discussed side practices/income on ranching properties to help with sustainable living in rural communities, diversifying conservation with other options for growing commodities other than hay, wheat, barley, etc., for supplemental income to support the ranch. After her discussion, Laura Kiehl showed everyone her thriving hops crop, and discussed all that is involved in starting and maintaining the hops in an everchanging environment in eastern Montana.



Kid's Education Day

September 4th marked the PCCD's Annual Kid's Ag & Conservation Education Day. Seven stations (& 17 presenters) presented on bees, fish, invasive species, fire (fire engine), fossils/dinosaur bones, soils, and wildlife tracks/scat identification.



Gardening Workshops

We had a Homesteading Workshop May 8th. The group learned about heirloom seeds, and had two hands on activities making homemade butter in a jar and bread from a bag. They also learned about atmospheric canning.



Applicators Class

Our annual Applicators Class was September 11th. Stephen Vantassel from the MT Dept. of Ag gave interesting presentations on varmint control (raccoons, mice & prairie dogs) and folks that attended were able to get 3 credits towards their applicator license.

Tree Program

We work with Lincoln Oakes Nursery out of North Dakota for our annual tree sales. We had around 250 trees picked up May 2024, and so far have around 60 trees ordered for the 2025 spring trees sale. The trees are delivered by FedEx and large there а variety to choose from






• NRCS provides conservation planning assistance on a request basis through working agreements with the conservation district. They also provide office space for the PCCD.



- DNRC provides our conservation district state-funded grants that we use for district operations, implementing on-theground projects, delivering educational workshops/classes to youth and adults, and assisting landowners with innovative conservation practices.

- The PCCD is the fiscal sponsor for the MRCDC. We work closely with the Missouri River Conservation District Council: Attend meetings, take minutes, help with the River Rendezvous events and help as needed with other duties assigned.
- The PCCD is the fiscal sponsor for the Musselshell River Coalition and we work closely with the MWC: Attend meetings, take minutes, MWC newsletter layout and design, put together the MWC new website and maintains their website and social media. Last summer purchased two EZ Ject lances last summer for Woody Invasives treatment




- Winnett ACES set up a Conservation Committee with the goal of funding conservation projects around the Winnett Area.


